Everybody was off mingling and enjoying the beautiful summer day. I found myself longing to go skinny dipping, but also having this inner fear that would not subside. I sat on that beach blanket for what seemed

like hours--- thinking and analyzing the whole situation. Scared to death, that people were staring at me. Well- they were! I was wearing jeans and a turtle neck shirt! ☺

I decided to walk down the river a bit. I stumbled upon a swimming hole, that was hidden by the over growth of a river side tree. I rolled up my pants, and decided to wade in the water. I remember it feeling so cool and refreshing. I kept looking around, scared that someone may see me. In fact, many people were walking by me along the river and had no idea I was there or they just paid no attention?

It was probably the heat and the attire that I was wearing, but I decided to go for it. I slowly began to undress and immerse myself into the refreshing waters of the Wisconsin River. I remember the wonderful feeling of freedom washing over me. It was so overwhelming that I began to weep. I wept for my freedom, myself, my body, and most importantly- my inner spirit. In an instant I was feeling what I had known as a child and young adult. The raw emotion was overpowering. I was free and unafraid for the first time in a very long time.
